Heard Sri J.J. Munir, learned counsel appearing in support of the writ petition and Sri R.A. Akhtar, Advocate appearing on behalf of respondent no. 3.

Having heard the learned counsel for the petitioners, learned Standing Counsel appearing for the respondent nos. 1 and 2 and learned counsel for the respondent no. 3, this Court finds that the controversy raised in this petition stands settled in light of the judgment rendered by a Division Bench of this Court on 25.9.2014 in Special Appeal Defective No. 376 of 2014. The Division Bench while deciding the said special appeal had upheld the right of unaided minority institutions to effect 100% admissions of their choice without intervention of the State Government. This of course bearing in mind the inter se merits of the candidates. Following the above judgment, various other writ petitions have come to be disposed of by this Court on similar terms.

Accordingly and in view of the above judgment, this writ petition stands disposed of directing the respondent no. 3 to act in accordance with the directions issued by this Court and the finding which stand recorded in the judgment dated 25.9.2014 referred to herein above.

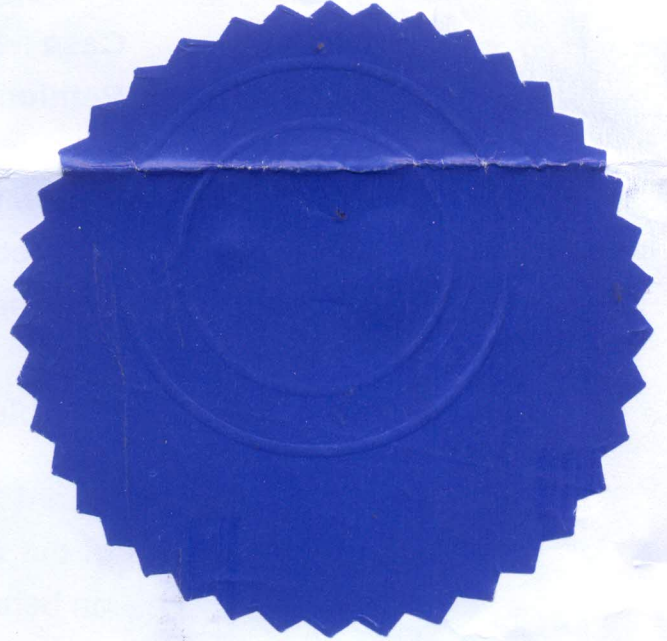


